Employer certificate

This certificate constitutes the basis for a Swedish school abroad's right to government grants for the education of Swedish pupils living abroad. The information requested is based on Section 3 of the Ordinance (1994:519) on Government Grants for the Education of Swedish Children and Youth Living Abroad. The first section of the form is to be completed by the school or the guardian and the second section is to be completed by the quardian's employer.

Legal entity refers to, for example, companies, limited liability companies, partnerships, associations and foundations. In order for an employer according to this certificate to be approved, the employer must actively be conducting operations.

Information that is marked with an asterisk (*) is compulsory information.

State the manner in which the service is the reason that the guardian is living outside Sweden *
The guardian must live outside Sweden due to his/her service pursuant to Section 3 of the Ordinance. This means that the service must be the reason that the guardian must live outside Sweden. The employer does not need to be established outside Sweden, but duties must be the reason that the guardian is posted outside Sweden.
To be signed by the employer (not the guardian)
An appropriate person to sign is, for example, the CEO/President/Managing Director, HR officer or the equivalent who has the insight into the operations as required to be able to certify what is stated by the completed certificate is accurate.
